## **Short Description**

This course offers a historical study of the English language including, Middle, Modern, and American English. We will address the nature and mechanisms of language change over time and social, political, and other historical conditions related to such changes. We will also attend to phonology, morphology, syntax, lexicon, semantics, and the literature and culture of the different historical periods. Class activities involve online lectures, discussions, group work, and presentations. You are on a strict weekly schedule of reading assignments from the Origins and Development of the English Language book. You may read the Bryson book (Bill Bryson The Mother Tongue English& How It Got That Way) at your own pace. Each week after the first you will have a homework assignment and short presentation.

## **Course Objectives**

The main objectives are:

- To challenge and provide an alternative perspective to the traditional narratives of English language history. The questions commonly held assumptions about the language's evolution.
- To dispel myths and misconceptions about the English language's development, particularly those related to its purity or linguistic decline.
- To emphasize the complex and multifaceted nature of language evolution, showing that it is not a linear progression but a dynamic, unpredictable process.
- To delve into the concept of language contact, showcasing how English has been influenced by contact with other languages, including Old Norse, French, and Latin, and how this has shaped its structure and vocabulary.
- To place the English language within its historical context, demonstrating how historical events, such as the Norman Conquest, have had a profound impact on the language's development.
- To provide sociolinguistic insights into how English has evolved in various social and cultural contexts, shedding light on the influence of social factors on language change.

- To discuss the diversity of English dialects and accents, showing how different varieties have developed over time and the role they play in shaping the language.
- To explore how English has evolved as a global language, touching on the spread of English through colonization, trade, and modern globalization.
- To address the idea that languages evolve and change rather than simply decaying, highlighting that linguistic change is a natural and inevitable process.
- To discuss how the historical development of English has influenced contemporary varieties and usage of the language.
- To make the topic accessible to a general audience, using engaging and approachable language and examples to explain complex linguistic concepts.
